Extrusion Attachments - 12, 22. Biplanar Attachments - 11, 21

Duration of Treatment: 8 months

Critical Appraisal: Good finish achieved in stipulated time frame. Tighter contacts could have been achieved with refinement aligners.

Retention Protocol: Upper and lower lingual bonded retianer.

Removable essix retainer at night time wear for 1 year.

Chief Complaint: Spaces in upper and lower front teeth. **Diagnosis:** Angles class I malocclusion with midline diastema in upper anteriors and mild crowding in lower anteriors .
