Retention Protocol: Frenectomy and Upper and lower fixed retention and Removable essix retainer at night time wear for 1 year.

Chief Complaint: Anterior proclination and crowding. Diagnosis: Angles class 1 malocclusion with anterior crowding and Proclination.

Treatment Plan: Proclination and crowding corrected.

Case Type: (26 Sets)

Attachments: Retentive attachments: 16, 14, 24, 26, 36, 34, 44, 46

Mesiodistal Attachment – 12, 11, 21, 22.

Duration of Treatment: 13 months.

Critical Appraisal: Results achieved in time Bite settling required.

Retention Protocol: Frenectomy and Upper and lower fixed retention &Removable essix retainer at night time wear for 1 year.

Chief Complaint: Anterior Crowding and spacing correction. **Diagnosis:** Angles class 1 malocclusion with anterior crowding and spacing in both arches.

Retention Protocol: Frenectomy and Upper and lower fixed retention & Removable essix retainer at night time wear for 1 year.

Chief Complaint: Proclination correction. **Diagnosis:** Angles class 1 malocclusion with anterior proclination.
