**Diagnosis:** Angles class II malocclusion with moderate crowding in upper and lower anterior teeth.

**Treatment Plan:** Stagewise decrowding planned to avoid intra-arch collision and smooth movement of teeth. Some expansion planned as well to create more space without flaring the teeth a lot. IPR has been done in upper and lower arch for creating space for decrowding.

Case Type: Intermediate category (29 sets)

**Attachments:** Retentive attachments - 16, 14, 24, 26, 36, 33, 43, 46. Bi planar Attachments – 12, 11, 21, 22. Vertical Attachments – 31, 41

**Duration of Treatment:** 15 months including refinements

**Critical Appraisal:** Better alignment should have been achieved by more refinement aligners.

Retention Protocol: Upper and lower lingual bonded retianer.

Chief Complaint: Crooked upper and lower front teeth

. **Diagnosis:** Angles class I malocclusion with mild spacing in upper and lower anterior teeth. Mild anterior open bite seen.

Attachments: Retentive attachments - 16, 26, 36, 34, 44, 46.

Extrusion Attachments – 12, 22.. Vertical Attachments – 32, 31, 41, 42

**Duration of Treatment:** 7 months.

Critical Appraisal: Good results achieved within stipulated time frame. Some

periodontal intervention might be needed.

Retention Protocol: Upper and lower lingual bonded retianer.

**Chief Complaint:** Spaced and forwardly placed front teeth. **Diagnosis:** End On molar relationship with mild spacing and proclined upper and lower anterior teeth.
